### Helpful Information...

- Please keep in mind that we rely on you to provide skilled team leaders for your group. An ideal ratio is 1:4, so for a group of 20 there would ideally be 5 skilled leaders. No skills? No problem! We coordinate and supervise the projects from start to finish and will be available for any questions you may run into.
- We recommend that you procure a substantial down payment of \$100 and make it non-refundable so people don't go wishy-washy on you. Once you reserve a bed, it is no longer available to other groups or individuals, so please be respectful of that.
- The participant fee covers supplies for construction, meals, and lodging. This does not cover travel meals or transportation. Transportation to, from, and while in the field is the responsibility of the team members.
